Payment Policy

All merchandise and services selected must be **paid in full** or secured by insurance **before the day of the funeral**. Past defaults by customers have made it impossible for us to extend credit to **anyone**.

Payment By Insurance

- Policies used to finance funeral expenses must be at least two years old unless the cause of death is accidental.
- Policies used to finance funeral expenses must be assigned to Pruitt Funeral Home, by the beneficiary for the amount of the expenses.
- Policies used to finance funeral expenses must have a beneficiary who is at least eighteen years old.
- In the case of multiple beneficiaries, all beneficiaries must sign the assignment form.

Other Payment Methods

- Cash advances on credit cards
- Loans from banks or loan companies
- Family and friends--in many cases family members are willing to contribute towards the payment of the funeral expenses.

Other Limitations Concerning Payment

- Estates--in the case where the deceased has an estate, payment for funeral expenses **must be paid in full before the day of the funeral**. We cannot carry the cost of the funeral for the length of time it takes to settle an estate.
- Lodge or club benefits--the length of time it takes to collect these benefits makes them unacceptable for payment of funeral expenses.

Please take this policy into consideration when making your selection of services and merchandise.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

This list does not include prices for certain items that you may ask us to buy for you, such as cemetery or crematory services, flowers, and newspaper notices. The prices for those items will be shown on the statement we provide describing the funeral goods and services you selected.

Basic Services of Funeral Director and Staff and Overhead **\$1,695**
Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs. **This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)**

Embalming **\$950**
Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement, such as direct cremation or immediate burial, that does not require you to pay for it.

Direct Cremation

Our charge for a direct cremation (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; transportation to crematory; necessary authorizations; the cremation process; and initial container. No other services or merchandise are included in this fee. **If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard.**
